"XONSUX", registered to 2002 Lexis RX3, [REDACTED]

Dear Mr. or Ms. Wright,

The Division has recently received a complaint from a citizen concerning the license plate "XONSUX" as being obscene or ethnically offensive.

When you applied for this plate, an electronic screening failed to recognize the plate as conveying an obscene or ethnically offensive message. Plate applications are screened electronically for obscene, offensive or racially/ethnically derogatory combinations of letters and numbers. Unfortunately not all are caught at the time of application or issuance.

As the plate "XONSUX" is or may be interpreted by persons viewing the plate as ethnically offensive or obscene we must revoke the registration and recall this plate.

You are hereby directed to immediately surrender the plates to the Division of Motor Vehicles. Please submit the original or a copy of this letter, along with the plates, to any DMV Office where we will issue a temporary plate, at no fee, to be used while awaiting issuance of a new personalized plate, which is not deemed offensive. We will apply the \$30 personalize plate fee you have already paid, to another plate of your choice, if available and not considered obscene, offensive and or racially/ethnically derogatory in nature.

You may request an administrative hearing to contest the Division's revocation and recall of the license plate "XONSUX". The administrative hearing is an informal hearing and technical rules of evidence do not apply. You may be represented at the hearing by an attorney, however an attorney is not required and if you choose to be represented by an attorney, you do so at your own expense.

To request an administrative hearing, you must do so in writing by the close of business on June 9, 2006. Address your written request to **Division of Motor Vehicles, Attn: Carl Springer, 3300 Fairbanks Street, Suite B, Anchorage, AK 99503**. Please state your reasons why you do not believe it is appropriate to revoke the registration and recall this plate.

Failure to request an administrative hearing, in writing, by the above date and time, will waive your right to a hearing and the Division's revocation of the registration and recall of the plate will be affirmed and final.
