Publishing climate and sustainability news and commentary: Grist published more than 800 articles on climate and sustainability topics during the fiscal year, ranging from short news items to in-depth interviews and features. The organization reached an average of 2.6m readers per month, including website visitors, email subscribers, and offsite (primarily social-media) audiences.

Fostering civic engagement: Grist's goal is to create a vibrant community of people who support sustainability; make sustainable choices and encourage their communities to do the same; and encourage readers to use social media and other tools to activate their personal networks and to create lasting change.

Train a new generation of journalists: By providing hands-on journalism experience as well as exposure to leading environmental thinkers, the Grist Fellowship Program trains early-career journalists to become effective environmental communicators. Grist hosts groups of five fellows for six-month terms. Fellows participate in research and story generation, crafting investigative stories and ground breaking multimedia projects.
